Duties and Responsibilities :

1. Ensure door step delivery of allotted food grains as per provisions of the National Food Security Act.-2013
2. Ascertain the distances of godowns of each GPSS and WCCS from designated FCI depots.
3. Ascertain the distances of Fair Price shops/Fair Price shop agents of GPSS from concerned GPSS/WCCS godowns.
4. Invite expression of interest from Transporters Association along-with rate of transportation of food grains.The rate will be valid for 1 year.
5. Ascertain the quality of food grains to be transported at both the level as mentioned at point 2 and 3 above.

This order will come into force with immediate effect.
