Detailed tender papers may be purchased from the office of the undersigned during office hours on all working days up to **29-03-2019** on cash payment of the requisite fee as mentioned in the Table above.

Intending bidders are to furnish 1) Requisite Earnest Money (2% of Bid Value for General Category & 1% for SC/ST/OBC/Unemployed Graduate/Diploma Engineers) in the form of Call Deposit/ Fixed Deposit of any nationalized bank duly pledged to the Deputy Commissioner, Barpeta 2) attested copies of up-to-date Registration Certificate (Valid up to 2018-19) of PWD(Building) 3) GST Registration & GST Clearance Certificate 4) PAN Card 5) Work Order / Experience Certificate of similar nature of work (In respect of Group A, B & C) done in connection with Elections (in Barpeta Sadar) in the last 5 years.

5. If the tender can not be received and opened in the due date owing to some unavoidable reasons or holidays etc., the same will be received and opened on the next working day at the same time and place.

6. Sealed Bids/Tenders must be delivered to the Deputy Commissioner, Barpeta on or before **2-00 p.m. of 29-03-2019** in his office.

7. Prospective Bidders should inspect the site before submission of Bid/Tender

8. Bid/Tender is to be submitted separately for each Group.

9. The undersigned reserves the right to issue the tender papers to the Bidders and to accept or reject any or all tenders without assigning any reason thereof. The undersigned will not bind

itself to accept the lowest tendered rate. In respect of acceptance of rate for awarding the contract, the decision of the undersigned shall be final and binding. 10. Bidders must quote rates considering the latest Govt. Order/Circular/Notification on GST.

11. The rate must be quoted in flat % basis, both in figure and words, on above / as per / below the bid value as mentioned in the NIT. In the event of any discrepancy/doubt the rate quoted in words will be considered correct and final.

12. Any correction on the tender should duly be signed by the tenderer. No overwriting will be entertained.

13. Once the tenderer is accepted no request for enhancement of rates will be entertained.

14. Payment will be made subject to the availability of fund under the appropriate head of account.
