Notice inviting Expression of Interest (EOI) for empanelment of contractors to carryout works
under MSDP

Last date of receipt of EOI:- 7 days from the date of the advertisement. In case the 7th day falls on a holiday, the next working day will be considered as the last day

Sealed Expression of Interest (EOI) affixing court fee of Rs. 8.25 are invited from registers Class-I Contractors of PWD(B), Deptt. for various construction works (Const. of ACR/Hostels/Toilets. etc.) under MSDP 12th plan. A list of qualified Contractors/Firms will be prepared for participating further bidding process.


The EOI complete in all respect must be submitted to the Deputy Commissioner, Barpeta at Planning & Development Branch, Barpeta.

Eligibility criteria for submission of EOI:-

1. Financial Strength(Turnover as per last 3 years annual statements to be certified by CA)
2. Contractor should have completed at least a single work of a minimum Rs. 35.00 lakh within a year.
3. Turnover minimum 1 cores in a financial year.
4. Contractors having Registration Certificate for the current year.
5. Contractors having Income Tax Clearance Certificate.
6. Contractors having Sales Tax Clearance Certificate.
7. Contractors having VAT Registration Certificate
8. Contractors having PAN Card.
9. Certified copy of duly executed Power of Attorney by the name of tenderer authorized representative to act on behalf of the contractor.
10. In no cases high bid price will be accepted.
11. Tender cost(Rs. 2000/- per tender paper)
12. Any bidder who bid below 10% should pay in the form of Bank Draft(BD) as additional security money to be fixed by the authority.
13. Bank finance certificate.

OTHER CONDITIONS:

1. Every applicant must show his willingness to do the works as per model estimate under SSA/RMSA which is prepared under scheduled rates for the year 2013-14 of APWD(B) and SSA assessed rate.
2. No compensation will be paid by the department for any damage done to the private properties in execution of work.
3. Suitable water supply and electricity arrangement for staff and labourer as well as for the work.
4. Suitable fencing barrier, sign board, caution board, direction board and signals including parafer and electric signals where necessary at works and at approaches to protect public and the employees from the accidents.

5. No compensation will be paid by the Department for loss and damages to contractor's materials during construction.
6. Compensation including cost of any suit for injuries to person and also which may become payable due to operation of workmen compensation act.
7. **The scope of Sub-Contracting will not be allowed anyway.**
8. Even though the bidders meet the above qualifying criteria, they are subject to be disqualified and legal action may be taken if they have: (i) Made misleading or false representations in the forms, statements, affidavits and attachments submitted in proof of the qualification requirements; and / or record of submission of any false / fake document(s). (ii) Record of poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion, litigation history, or financial failures etc. (iii) Time is essence in these works. So no extension of time shall be entertained in any way. The amount of earnest money is 2% of the estimated cost of construction for each work. All duties, taxes, royalties, cess, [including 1% Cess under Building and other Construction Workers (Regulation of Employments & Condition of Service) Act, 1996], toll, taxes and other levies payable by the Contractor under the Contract to the State / Central Government for any other cause, shall be included in the rates, prices and total Bid price submitted by the bidder.
9. The applicant may to inspect the work site of the proposed work before quoting their rates. No plea/complain about the site approach road, natural or political disturbance etc. shall not be entertained in any way. Further they may visit to the planning and development branch for examine plan & estimate for their convince.
10. Running bill will be entertained only after 50% physical progress of the work subject to availability of fund.
