Sealed Tender affixing non refundable court fee stamp of Rs.8.25 (Rupees eight and paise twenty five) only are hereby invited from the registered/Licensed Wholesaler firm for supply of the following items for calamity Relief Operation -2019 for Barpeta Sadar Sub-Division as per items and terms & conditions noted below. The tender will be received up to **3.00 PM of 14/ 05 /2019** and will be opened on the same day at **3.30PM** in presence of the intending Tenderer or their authorized representatives. If the last date of submission / opening tender to be a holiday, the next working day will be treated as submission/ opening day. The price should be quoted inclusive of Income Tax & GST. Rate should be quoted in figures and words with signature on any correction if any. Tender holder should mention their full address with contact number. The undersigned is not bound to accept the lowest quoted price and reserves the right to accept any/all tenders without assigning reason thereof.

TERMS & CONDITIONS:

1. Supply of sub standard item will invite termination of contract for the purpose for which it is quoted.
2. Rate for all the items should be quoted as per unit shown below against each item.
3. The rate for specified unit should be for net quantity only,i.e. excluding weight of packing materials.
4. Delivery/construction of items must be done at the places to be mentioned in the supply order within the specified time.
5. Payment will be made on availability of fund.
6. Tenderer (excluding pit Latrine) must have whole sale/sub-whole sale /Retail license under the Assam Trade Articles (Licensing and control) order 1982 with up-to date renewal.
7. Tenderer must have their own godown/ware house for stocking of materials with necessary storage license.
8. Loading and unloading cost will not be entertained.
9. Tenderer should mention about the stock position of the item quoted for on the day of dropping tender.
10. Tenderer must enclose PAN card, and up-to-date income tax and GST clearance proof & GST return certificate.
11. Tenderer's firm should be located within the Barpeta district.
12. The Food Inspector will examine the quality of the edible items and he has the right to reject any items if he found sub standard and inedible.
13. All disputes relating to the tender shall be within the jurisdiction of Barpeta dist.
14. The undersigned reserves the right to cancel the contract at any time without assigning any reason thereof.
15. If the tender does not respond properly or does not supply the material in time the tender will be cancelled and the party will be blacklisted for next 3(three) years to participate in any bidding process in Barpeta district.
