**SHORT NOTICE INVITING TENDER**

Sealed tender affixing non refundable Court Fee of Rs. 8.25 ( Rupees Eight & Paise Twenty Five) only eventually to be drawn up to F-2 form with a validity period of 180 days are invited from the eligible contractors/ firms of Class-I (A,B,C) & Class-II for the works as per **Annexure: I** under Multi Sectoral Development Programme ( MSDP)-12<sup>th</sup> Plan separately for each Group & will be received by the under signed in the Office of the Deputy Commissioner, Barpeta up to **2-00 PM** on **08-03-2018** & will be opened on the same day at **3.00 PM** & venue in presence of intending tenderers or their authorized representatives.

Details of tender/ estimates etc may be seen at the Planning & Development Branch, DC's office, Barpeta during office hours in working days.

Tender documents may be collected from the Planning & Development Branch, DC's Office, Barpeta from **27-02-2018** up to **12. 00 PM** of **08-03-2018** on payment of cash amount of Rs. **1000/-** for each Group of Work separately. No tender will be issued after the specified period.

If for any reason, the date of receiving/ opening of tenders happen to be an unforeseen Bandh/ declared Holiday, the tender will be received/ opened on the next working day at the same specified timings & place.

**Eligibility Criteria:-**

1. Rates are to be quoted in figures & words legibly in flat percentage basis as per APWD SOR :2013-14.
2. Terms & conditions will be as per APWD F-2 Form.
3. Tenderer will have to deposit **Earnest Money** as follows:  
For General category: 2% of Work value  
For SC/ ST/OBC/MOBC/UGE/Unemployed engineering graduate: 1% of Work value
4. Tenderer should submit the copies of up to date GST Registration/GST Registration/clearance Certificate, Registration Certificate, VAT Certificate, Income Tax Clearance Certificate, PAN Card, WC-II & Labour License etc duly attested by the Gazetted Officer at the time of purchasing Tender Papers along with the application for acquiring tender documents without which no tender documents will be issued to them.
5. Bid Security 2% should be in the form of FDR/CDR in favour of the Deputy Commissioner, Barpeta.
6. Bids of more than 5 % below the rate will have to justify technically.
7. Construction has to be done as per the specification/ Model Drawing.
8. Tender must be submitted in sealed envelope separately for each Group of work addressing it to the Deputy Commissioner, Barpeta super scribing the name of Group of Work tendered for & to legibly mention their names, address, contact No.
9. In case the evaluated bid amounts are found equal, preference will be given to the bidder having more experience on similar nature of works executed earlier.



10. Contractors should have completed any similar nature of work value not less than 40% of proposed project cost.
11. The Deputy Commissioner, Barpeta does not bind to accept the lowest tendered rate & reserves the right to reject or accept any tender or to postpone/ cancel/ withdrawn/ modify the works & the process of tender at any time without assigning any reason thereof.
12. The SNIT will form a part of the contract agreement.
13. One contractors/ Firm will be allotted to participate in the tendering process for 3 groups only.
14. The contractors/ firm must start work within 15 days after issue of work order. Otherwise the work order will be automatically cancelled without any notice, and the same will be allotted to other group.
